**Sub: Admissibility of Personal Protective Equipment (PPE) kit for treatment of patients under West Bengal Health Scheme.**

**Personal Protective Equipment (PPE) kit** is an essential consumable for attending any In-Patient who suffers from Covid-19 and requires treatment at Hospitals in the State. Currently, there is no provision for admissibility of such PPE kit in the existing guidelines of West Bengal Health Scheme.

The Governor is pleased to allow admissibility of Personal Protective Equipment (PPE) for the treatment of any In-Patient who suffers from COVID-19 in empanelled HCOs as per ceiling of quantity and rate stated below:


