of Procedure and Conduct of Business in the West Bengal Legislative Assembly, the publication of the following Bill, together with the Statement of Objects and Reasons which accompanies it, in the Kolkata Gazette, the Bill and the Statement of Objects and Reasons are accordingly hereby published for general information :-

Bill No. 12 of 2010 THE WEST BENGAL ACQUISITION OF HOMESTEAD LAND FOR AGRICULTURAL LABOURERS, ARTISANS AND FISHERMEN (AMENDMENT) BILL, 2010.

A BILL

To amend the West Bengal Acquisition of Homestead Land for Agricultural Labourers, Artisans and Fishermen, Act, 1975.

Whereas it is expedient to amend the West Bengal Acquisition of Homestead Land for Agricultural Labourers, Artisans and Fishermen, Act, 1975, for the purpose and in the manner hereinafter appearing;

It is hereby enacted in the Sixty-first Year of the Republic of India, by the Legislature of West Bengal as follows :-

1. (1) This Act may be called the West Bengal Acquisition of Homestead Land for Agricultural Labourers, Artisans and Fishermen (Amendment) Act, 2010.

(2) It shall come into force at once.

2. In section 4 of the West Bengal Acquisition of Homestead Land for Agricultural Labourers, Artisans and Fishermen Act, 1975, for the figures, letters and words "26th day of june, 1975", the figures, letters and words "31st day of December, 2009" shall be substituted.

STATEMENT OF OBJECTS AND REASONS.

It is considered necessary to amend section 4 of the West Bengal Acquisition of Homestead Land for Agricultural Labourers, Artisans and Fishermen Act, 1975 (West Ben. Act XLVII of 1975), so that any land in rural areas not exceeding 0.0334 hectare which has been in possession of an occupier i.e. an agricultural labourer, an artisan or a fisherman by constructing homestead thereon on the 31st day of December, 2009, shall stand acquired by the State Government and shall thereupon stand transferred to, and vest absolutely in favour of, such occupier.

2. The Bill has been framed with the above objects in view.

3. There is no financial implication involved in the Bill.
