# 6. Training :

The Candidate will be required, after his selection, to undergo a course of training as may be prescribed by the appointing authority. At the end of the training an examination will be held by the Officer-in-Charge of the training and the trainees who pass the examination successfully will be appointed. Those who fail to pass the examination will be discharged.

In special cases, the appointing authority may by order in the public interest exempt a candidate or a class of candidates from undergoing the training.

15 percent of the appointments will be made from candidates belonging to the Scheduled Castes and 5 percent from those belonging to the Scheduled Tribes, subject to availability of qualified candidates.

## 7. Training :

The candidate will be required, after their selection, to undergo a course of training as may be prescribed by the appointing authorities. At the end of the training an examination will be held by the officer-in-charge of the training and the trainees who pass the examination successfully will be appointed. a) For Special Revenue Officer, Grade I

The appointment shall be by selection from the surplus Gazetted and non-gazetted staff of the different Departments of Government.

b) For Special Revenue Officer, Grade II :-

the appointment shall be :-

- i) by selection from the surplus Gezetted and non-Gazetted staff of the different departments of Government.
- ii) by selection from the temporary Settlement Kanungos, Grade I who have put in at least five years' service as Settlement Kanungo, Grade I,
- iii) by promotion from the permanent Settlement Kanungos.

The selection for 2(a), 2(b)(i) and 2(b)(ii) shall be made by the Selection Board constituted by Government for the purpose. The same Selection Board shall also recommend to the Appointing Authority the cases of promotion under clause 2(b)(iii) in accordance with a list prepared by the Selection Board the priority in which has been fixed according to merit.

3) Educational Qualifications :-

For appointment under rules 2(a) and 2(b)(i) the candidate must possess at least a B.A., B.Sc., or B.Com. Degree. In case of appointment under rules 2(b)(ii) and 2(b)(iii) no minimum educational qualification is prescribed.

4) Age limit and physical fitness :-

A candidate for appointment under 2(a) and 2(b)(i) must be below the age of fifty years and physically fit for outdoor work. For appointment under rules 2(b)(ii) and 2(b)(iii) no age limit is prescribed.

5) Training :

The candidate Selected under rules 2(a) and 2(b)(i) may be required after selection to undergo a course of training as may be prescribed by the Board of Revenue. At the end of the training an examination may be held by the Officer-in-Charge of the Training and the trainees, who can pass the examination, may be appointed to the posts. The selection of unsuccessful candidates may be cancelled. In special cases, the Board of Revenue, may, if it considers necessary and in the public interest, exempt a candidate or a class of candidates from undergoing the training.

Persons appointed under 2(b)(ii) and 2(b)(iii) shall not be required to undergo any training.

The pay, method of recruitment and the qualifications required for recruitment to the posts of Land Acquisition Kanungos, shall be detailed below :

1) Pay : Scale of Pay Rs.175-7-245-8-325.

2) Appointing Authority : The Dy. Secy., Land and Land Revenue Department, Government of West Bengal.

3) Method of Appointment : By selection from the following personnel, namely.

i) Kanungo, Grade I, of Settlement Deptt. and

ii) District Kanungos who are continuing in the Land Acquisition Offices in the districts.

Or, By direct recruitment for which the minimum qualification shall be a pass certificate of I.A., I.Sc, or I.Com. Examination or any other examination equivalent thereto from any recognized University, or a pass certificate of First year of the three years' Degree course.

4. Selection in all cases shall be made by a selection committee to be constituted by the State Government for the purpose.

5. Preference in all cases shall be given to those who have got experience in Land Acquisition work.

6. Age for direct recruitment : Between 20 to 25 years on the 1<sup>st</sup> day of the year of recruitment. The age limit is relaxable in the case of specially qualified and experienced candidate.

No.14863-L.Ref. - 8<sup>th</sup> September 1967. - The Governor is pleased hereby to constitute the West Bengal Subordinate Land Revenue Service, Grade I, and in exercise of the power conferred by the proviso to article 309 of the Constitution of India, to make the following rules regulating the recruitment and the conditions of service of persons appointed to such service, namely :-

#### RULES

The pay, method of recruitment and the qualifications required for recruitment to the West Bengal Subordinate Land Revenue Service, Grade I, shall be as detailed below :

- 1. Pay : Scale of pay : Rs. 200-400
- 2. Appointing Authority : The Secretary, Board of Revenue, West Bengal.
- 3. Method of Recruitment :
- (a) 66.2/3 per cent. of the vacancies shall be filled up by direct recruitment and 33.1/3 per cent. by promotion from Circle Inspectors (Land Reforms), Kanungos, Grade II, and Zilladars (Canal Revenue).

- (b) 15 per cent. of the vacancies to be filled up by direct recruitment shall be reserved for candidates belonging to Scheduled Castes and 5 per cent. for candidates belonging to Scheduled Tribes, if suitable candidates are available.
- 4. Qualifications for direct recruitment :
- (a) Women candidates shall be considered to be unsuitable.
- (b) Age : Between 20 to 25 years on the first day of September of the year in which recruitment is made, the upper age – limit being relaxable for candidates already in the service of the State Government by the period of continuous service subject to a maximum of 5 years.
- (c) Education : candidates must have a Degree in Arts, Science, Commerce or Agriculture.
- (d) Other requirements :-
- (i) Good working knowledge of the Bengali language, written and spoken. (Candidates whose mother language is Nepali shall be exempted from this requirement, but will be required to pass, within a period of two years, a departmental examination in Bengali).
- (ii) Candidates must be in sound health and physically fit for continuous arduous touring in rural areas.
- (iii) A good record of extra-curricular activities, e.g. games and atheletics, N.C.C., Social Service, shall be considered to be desirable qualifications.
- 5. Procedure for direct recruitment :

Candidates fulfiling the qualifications shall be required to appear at a written examination in English, Bengali (or Nepali), Elementary Mathematics and General Knowledge. Those securing minimum qualifying marks at the written examination shall be called up for an interview before a Selection Board to be constituted for this purpose. Selection for appointment shall be made on the basis of total marks secured in the written examination and the interview.

6. Qualifications for promotion :- Circle Inspectors, Kanungos, Grade II, and Zilladars who have served for at lease five years shall be eligible for promotion.

7. Training :

(a) Candidates shall not be recruited direct into the service but shall be recruited as trainees for a period of six months during which they shall receive a consolidated allowance of Rs.200 per month. Before joining the training the selected trainees shall be required to furnish a bond with one surety under-taking to prosecute the course of training diligently, to complete the training and to serve in the West Bengal Subordinate Land Revenue Service, Grade I, for a least three years from the date of appointment or in default thereof to refund to the Government of West Bengal the allowances drawn by them during the period of training. The training shall be imparted at an institution, such as, the West Bengal Survey Institute, Bandel and shall include subjects, such as, cadastral survey, preparation of record-of-rights, revenue laws, elementary instruction in other Laws relevant to their work and, if possible, Agricultural practices and problems of the State.

(b) Circle Inspectors, Zilladars and Kanungos, Grade II, selected for promotion shall also undergo similar training for a period of six months during which they shall draw their pay and allowances as in the lower grade plus training allowance of Rs.50 per month to reimburse them for the additional costs of stay at the Training Institute.

(c) The trainees (whether direct recruits or selected for promotion) shall be appointed to the service on the successful completion of training, their performance being judged on the basis of both their sessional records and on an examination to be held at the end of the period of training.

(d) Trainees who do not apply themselves to the training with due diligence or fail to pass the End of Training Examination or are guilty of a breach of the rules of residence and discipline at the Training Institution shall be liable to be discharged without notice.

In notification Mo. 14863-L. Ref. dated the 8th September, 1967, a new service known as 'West Bengal Subordinate Land Revenue Service, Grade-I, has been constituted and the Rules for Recruitment to the Service have been framed. The new service has been constituted with the idea of combining the posts in cadres indicated below under the Land and Land Revenue Department and Board of Revenue, West Bengal, into one service.

- i) Settlement Kanungos, Grade-I.
- ii) Assistant Compensation Officers,
- iii) Junior Land Reforms Officers,
- iv) Revenue Officers (Loans)
- v) Land Acquisition Kanungos.
- vi) Permanent Settlement Kanungos.
- vii) Bhagchas Officers,
- viii) Enquiring Officers (Land Acquisition Department and 1st Land Acquisition Collector's Office )
- ix) Assistant Canal Revenue officers,
- x) Settlement Kanungos, Land Acquisition Kanungos and Junior Land Reforms Officers on deputation to other Departments.

2. The question of absorption of existing personnel in different cadres has been considered by Government. It has been decided that the existing incumbents in the different cadres indicated above should be absorbed in said service.

3. The Governor, is, therefore, pleased to direct that the existing incumbents of the cadres mentioned above whether permanent, temporary, quasi-permanent or with permanent status be absorbed in the said service in their same capacity with effect from the 1st April, 1968.

4. Formal orders of appointment will be issued in due course. Pending issue of formal orders, the existing incumbents are authorised to draw their present pay and allowances.

5. The cadres mentioned above should be treated as defunct as soon as the absorption of the existing incumbents in the West Bengal Sub ordinate Land Revenue Service, Grade-I is completed. Vacancies that would occur in the different cadres in the process of absorption should not be filled up.

6. The officers on their absorption in the new service will continue to draw their existing basic pay in the scale of Rs. 200-10-400/-. They will draw their next increment on the date on which such increment would have fallen due had they not been absorbed in the service now constituted. In addition they will draw D.A. and other allowances as admissible under the existing rules.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor is pleased hereby to make the following rules namely :

#### Rules

- 1. Short title and commencement
  - (i) These rules may be called the West Bengal Services (Unification of State Services) Rules, 1974;
  - (ii) They shall be deemed to have come into effect on the 1<sup>st</sup> day of March 1974.

2. Notwithstanding anything contained in any rules relating to pay and recruitment to any of the services mentioned hereunder, the West Bengal Junior Civil Service (Executive), the West Bengal Junior Commercial-Tax Service, the West Bengal Junior Agricultural Income-Tax Service, the West Bengal Junior Excise Service and the West Bengal Junior Educational Service shall each form a single service with the corresponding State Service with a Senior Scale of Rs.475-30-685-35-1,000-50-1,150 and a Junior Scale of Rs.425-15-500-20-700-25-825. Similarly, the West Bengal Junior Labour Service, the West Bengal Junior Food and Supply Service and the West Bengal Junior National Exployment Service shall each form a single service with the corresponding State Service with a Senior Scale of Rs.450-30-690-35-1,005-45-1050 and a Junior Scale of Rs. 400-15-490-20-750. There will not however be any Selection Grade for the Junior Scale in the Unified Services.

3. There will be an efficiency bar after the 6<sup>th</sup> stage in each of the aforesaid Junior Scales and the Junior Scale Officers will be eligible for promotion to the Senior Scale after six years of service in the Junior Scale provided their services have been fully satisfactory.

4. The initial pay of Junior Scale Officer on being promoted to the Senior Scale will be fixed therein under the provisions of rule 42(1)(i) of West Bengal Service Rules, Part-I, increased by one increment in the Senior Scale.

5. The unification of the services as mentioned in paragraph 2 above will not in any way affect the interests of the candidates who are already under recruitment through the competitive examinations already held by the Public Service Commission.

# Government of West Bengal Home Department Personnel and Administrative Reforms

#### **NOTIFICATION**

No.271-P&AR (WBSC) – 13<sup>th</sup>. January 1978 – In exercise of the power conferred by the proviso to article 309 of the Constitution of India and in supersession of all previous rules on the subject, the Governor is pleased hereby to make the following rules regulating recruitment to the West Bengal Civil Service (Executive), namely;

#### RULES

1. Short title and commencement : (1) These rules may be called the West Bengal Civil Service (Executive) Recruitment Rules, 1978.

(2) They shall be deemed to have come into force on the  $1^{st}$  day of March, 1974.

- 2. Definitions; in these rules
  - (a) "Commission" means the Public Service Commission, West Bengal
  - (b) "Service" means the West Bengal Civil Service (Executive).
- 3. Constitution of the service : The Service shall consist of the following persons, namely;

- (a) Persons recruited to the Service including those recruited to the West Bengal Junior Civil Services) before the Commencement of these rules; and
- (b) persons recruited to the Service in accordance with the provisions of these rules.

4. Method of recruitment to the Service : (1) Recruitment to the Service, after the commencement of these rules, shall be by the following methods namely.

- (a) By direct recruitment on the results of the West Bengal Civil Service (Executive) and Allied Services Examination for "Group-A" Services and posts, to be held by the Commission :
- (b) By promotion from the following feeder services/posts :
  - (i) Special Revenue Officer, Grade II
  - (ii) Land Reform Officer, Grade II,
  - (iii) Joint Block Development Officers,
  - (iv) West Bengal Junior Agricultural Service, provided that the officers of this category who opt for promotion to the WBCS (Executive) shall not be considered for promotion to the West Bengal Agricultural Service.
- (c) By selection in special cases from among persons, who are confirmed in a civil services/post under the State Government, not being a member of the service or holding any post as mentioned in items (i) and (ii) of sub-clause (b), as may be determined by the State Government in consultation with the Commission.

Provided that not more than fifty per cent. of the total number of posts borne in the cadre shall, at any time be filled up by persons recruited under sub-clauses (b) and (c) above.

(2) Subject to the provisions of these rules, the method or methods of recruitment to be adopted for the purpose of filling any particular vacancy or vacancies in the Service as may be required to be filled during any particular period of recruitment, and the number of persons to be recruited by each method shall be determined on each occasion by the State Government in consultation with the Commission.

(3) Notwithstanding anything contained in subrule (1) if in the opinion of the State Government the exigencies of the Service so require, the State Government may, after consultation with the Commission, adopt and prescribe such methods of recruitment to the Service other than those specified in the said sub-rule.

- 5. Qualification for direct recruitment : A candidate shall be
  - (a) a citizen of India as defined in Part-II of the Constitution of India.
  - (b) of good health and character and must be in all respect suitable for appointment to Government service;
  - (c) a graduate of a recognized University;
  - (d) of age not below 21 years but not more than 26 years on the 1<sup>st</sup> January of the year in which the examination for recruitment is held.

6. Appointment to the service : (1) The initial appointment of persons recruited to the Service under sub-rule (1) of the rule 4 shall be in the Junior scale of pay as attached to the Service.

Provided that the candidates who appeared at the competitive examination held by the Commission prior to the 1<sup>st</sup> March, 1974 and qualified for appointment to West Bengal Civil Service (Executive) shall be appointed to the Senior scale of pay as attached to the Service.

(2) A person appointed to the junior scale of pay under sub-rule (1) of this rule will be eligible for promotion to the senior scale of pay on completion of six years of service in the junior scale of pay, provided he has crossed the efficiency bar at the end of  $6^{th}$  year of service and his services have been fully satisfactory.

7. Recruitment by competitive examination : (1) The Competitive examination referred to in rule 4(1) above shall ordinarily be held annually by the Commission.

- (2) The Examination shall be conducted by the Commission in accordance with such procedure as may be adopted by it for holding the examination.
- (3) The syllabi of the examination shall be settled by Government in consultation with the Commission.
- (4) No candidate who does not belong to a Scheduled Caste or a Scheduled Tribe shall be permitted to compete more than two times for the examination.

Note : A candidate shall be deemed to have competed at the examination if he actually appears in any one or more subjects.

8. Conditions for promotion and selection to the service : (1) The minimum qualifying service for "promotion" and "Selection in special cases" to the service under clauses (b) and (c) of sub-rule 4 shall be six years of service in the respective feeder services/posts.

(2) The maximum age limit for "promotion" and "selection in special cases" under clauses (b) and (c) of sub-rule 4 shall be 52 years.

Under the existing system for the purpose of appearing in different recruitment examinations conducted by the Public Service Commission, West Bengal, candidates serving under Govt., Local or Statutory bodies are required to submit their applications through their appointing authorities or to submit 'no objection certificate' from their appointing authorities.

2. It has been brought to the notice of Govt. that very often the letters of permission of the appointing authorities in such cases do not reach the Commission's Office even after the finalisation of results. The Commission is thus placed in an embarrassing position.

3. After careful consideration of the matter it has been decided, in order to remove the practical difficulties mentioned in para 2, that persons already in Government service, who wish to appear at a competitive examination conducted by the Public Service Commission, West Bengal or wish to apply for a post, recruitment to which is proposed to be made by selection through the Public Service Commission, may submit their completed applications in the prescribed form direct to the Commission. They should, however, immediately inform the Heads of their Offices/Departments giving details of the examination/post for which they have applied, requesting them to communicate their permission to the Commission directly. In case the Head of Office/Department considers it necessary to with-hold the requisite permission he should inform the Commission within 30 days of the closing date for the receipt of the application. In case no such communication is received from the Head of Office/Deptt. it shall be presumed by the Commission that there is no objection on the part of the employing Deptt. to the candidature of the Govt. employee in question to be considered by the Commission.

4. The Administrative Deptts. are requested to bring these instructions to the notice of all concerned including attached and subordinate offices as well as public sector undertakings, local/statutory bodies under their administrative control.

## **MEMORANDUM**

Prior to amendment of rules for recruitment to the WBSLRS, Grade-I in 1981, appointments to the said services were made subject to satisfactory completion of a course of pre-service training. During the period of training they were allowed to draw a fixed amount of training allowance. Such trainees on satisfactory completion of training and fulfilment of other conditions were formally appointed to service on the time scale of pay attached to the services. But the period of pre-service training was not treated as Govt. Service.

2. A good number of employees who has been serving under different departments and offices of the Govt. in permanent and temporary capacities or with permanent and quasi-permanent status, having applied through their respective appointing authorities were also selected for undergoing training on open competition with outsiders. Some of them had been drawing pay at a stage higher than the initial of the scale of pay of the W.B.S.L.R.S. Grade-I. They had also to undergo the course of training and were formally appointed to the service after satisfactory completion of the training like freshers. Since the training was 'Pre-service one' such employees had to suffer break-in-service during the period which cost them the retirement and other benefits accrued by virture of their service under the same Govt. prior to joining the training course.

3. In consideration of the hardship of such employees both financial and otherwise and with a view to regularizing the matter the undersigned is directed by order of the Governor to say that the Governor has been pleased as a Special case to decide that :-

(i) The period of pre-service training of such Govt. employee be regularized by grant of leave. The leave salary should be restricted to half average pay in terms of rule 162 of W.B.S.R. Part(I). In addition, they would be entitled to fixed allowance as already drawn by them. In case of those who had no half pay leave or the required number of half pay leave at his credit at the time of joining the training course, the period not covered by half pay leave should be regularized by grant of extra-ordinary leave without pay which would qualify for pension etc. in terms of rule 30 of W.B.S. (D.C.R.B.) Rules, 1971 and in relaxation of rule 28 ibid.

(ii) Where necessary last pay drawn by such employees should be protected while fixing pay in W.B.S.L.R.S. Grade-I i.e. their pay should be fixed in terms of rule 42 of the W.B.S.R. Part-I read with rule 54 and 55 ibid and Finance Department's Memo No. 4997-F, dated 05.12.70 as the case may be.

(iii) The orders for regularization of break-in-service by grant of half pay leave or extraordinary leave without pay as the case may be as also for the protection of pay where necessary of such employees will be issued by the Board of Revenue, West Bengal. The charges on account of the leave salary for the period shall proceed as a special case against the appropriate budget head of the Board of Revenue, from which the salaries of the officers concerned are drawn.

#### MEMORANDUM

In terms of G.O. No.12946-PB II dated 17.12.85 the Governor had been pleased to regularize the period of Pre-service Training prior to joining the W.B.S.L.R.S. Gr-I in case of those Government employees who after putting in service for a considerable length of time had undergone the said pre-service training and eventually suffered breaks-in-service, by grant of half-pay leave what was due to them prior to their joining the pre-service training camp and extra-ordinary leave without pay in case of those employees who had no such leave or sufficient amount of such leave at their credit at the material time.

2. In course of processing such cases of regularization, it has come to the notice of the Board that a considerable number of Govt. employees could not join the training camps on the days following the days of their release from their previous assignments mainly due to the distance of the location of training camps from their previous place of posting. As a result they have suffered yet further breaks-in-service even if their break-in-service due to pre-service training itself is regularized under the G.O. referred to above.

3. In the above context the undersigned is directed by order of the Governor that the Governor after further consideration of the matter has been pleased, as a special case, to decide that such gaps between release from previous assignment and joining the pre-service training camp of such employees be regularized by grant of Earned leave or half-pay leave as might have been due to them at the time of their release from their previous assignment. In case of those who had no Earned Leave or half-pay leave or sufficient number of such leave at that point of time should be regularized by grant of extra-ordinary leave without pay which would however qualify for pension in terms of rule 30 of W.B.S. (D.C.R.B.) Rules, 1971 and in relaxation of rule 28 ibid.



"15.(<u>1</u>) By the 1<sup>st</sup> April of each year or soon thereafter the appointing authority, or such other authorities as may be empowered by Government, shall report to the Public Service Commission, West Bengal, the number of vacancies available for being filled on the results of the competitive examination mentioned in rule 7.

Appointing Authority : The District Land & Land Reforms Officer shall be the appointing 3. authority in respect of Bhumi Sahayaks for offices under his jurisdiction.

#### Method of Recruitment : 4.

(1) 75% of the posts shall be filled up by direct recruitment from candidates sponsored by Employment Exchange or in accordance with the policy laid down by the State Government in this regard from time to time.

Provided that department candidates possessing the essential qualifications for direct recruitment shall be eligible to apply.

(2) 25% of the posts shall be filled up by promotion of eligible Group 'C' or Group 'D' employees.

Note : Eligible Group 'C' or Group 'D' employee shall mean Group 'C' or Group 'D' employee who possesses the essential qualifications for direct recruitment, has completed five years of service, is on a scale of pay lower than that prescribed for the post of Bhumi Sahayaks and is not more than 54 years of age on the 1<sup>st</sup> January of the year in which promotion is considered.

#### 5. Qualification for direct recruitment

(i) A pass certificate in School Final/ Madhyamik Examination of the West Bengal Board of Secondary Education or equivalent.

(ii) Good working knowledge of written and spoken Bengali.

6. Age: The candidates shall not be less than 18 years of age and more than 35 years of age on the 1<sup>st</sup> January of the year in which the selection is made:

Provided that the upper age limit shall be relaxable up to 40 years for departmental candidates for direct recruitment.

#### 7. **Induction Training :**

The selected candidates will be required to undergo in service training for a period not exceeding three months. Those of the candidates who fail to qualify in the examination to be conducted at the conclusion of the training shall be forthwith discharged from service or reverted to the feeder posts, as the case may be.

1.0. The recruitment of LDC, Amin and Bhumi Sahayaks was long overdue. The L&LR Department after it had received clearance from the Finance Department by it's G.O. No.6807-ISU, dated 8<sup>th</sup> October, '99 had intimated the creation of additional posts. However, the further follow-up action could not initiated due to various reasons. Presently there is no further obstacle to the process and it should be carried out expeditiously.

2.0 Please find enclosed a statement regarding the available vacancies in the ISU for the cadres of LDC/Amin/Bhumi Sahayaks. Of the total vacancies available 30% is set aside for the exempted category. The rest has been decided strictly as per the guidelines of the Labour Department in G.O. No.500/100-EMP/1M-43/94, dated 7<sup>th</sup> October, 1997.

3.0 The total vacancies to be filled up on requisition through an Employment Exchange and the individual break up of categories viz. General. OBC, SC & ST have been given. It has been found that there are cases where recruitment to the SC/ST/EC/Promotion have been in shortfall to the prescribed requirement. This is proposed to be made up during this recruitment by adding/ deducting the requirement as is required respectively. No recruitment for the E.C. Category directly is proposed through this circular and the E.C. category shall be filled up as per the 100 point roster described in the Labour Department G.O. No. mentioned in Para 2.0. The promotion quota as prescribed in the recruitment rules is 10% of cadre strength for LDC and 25% in the case of Amins and Bhumi Sahayaks respectively.

4.0 Requisition in the prescribed form shall be placed with for the three cadres of LDC/Amin/ Bhumi Sahayaks with the Dy. Director of Employment if available or the District Employment Exchange Officer at the District Headquarter level in the **ratio of 25 names for every vacancy** with request to circulate the vacancies to all other Employment Exchanges **within the district** without fail. Names should be sent **within 30 days** positively. A copy of the Recruitment Rules should be also sent for better understanding. Under no circumstances should any Employment Exchange be left out of the process.

5.0 The requisition should clearly state a further stipulation of providing the names of physically handicapped candidates of any caste category @ 3% and ex-servicemen @ 5% of any caste category invariably as per Labour Department Circular no.500(100)-EMP/IM-43/94, dated 7.10.97. In case of failure to send the names of these category or shortage, the Employment Exchange should without further delay intimate to you the paucity of candidates. You should keep in touch with the Employment Exchanges constantly.

6.0 The recruitment process would involved considerable manpower and energy as the last recruitment took place after the creation of the ISU in 1989. I would however expect that the process should be completed by 15.02.2001 positively for all the three cadres of LDC, Amin and Bhumi Sahayak. A guideline for the recruitment procedure to be followed henceforth is also being sent shortly.

# **RECRUITMENT PROCEDURE FOR LDC/AMIN/BHUMI SAHAYAK**

After the approval of the Re-organization of the Integrated Set Up which was communicated by the Land & Land Reforms Department G.O. No.6807-ISU, dated 08.10.1999, it is now incumbent that the recruitment process should start immediately to ensure that the work is completed expeditiously before the onset of Elections. Hence, it is best that a clear cut recruitment procedure should be put in place well ahead to ensure that there are no untoward lapses on our part and which can vitiate the whole process altogether.

The **recruitment procedure** ordinarily consists of the following steps/stages :

1. Clearance of vacancies by the Directorate.

2. Notification of vacancies to all the Employment Exchanges within your district.

3. Sponsoring of candidates from the Employment Exchange.

4. Intimation to the Directorate regarding the number of candidates, availability of names category-wise, selection of venue and the prospective dates for the conduct of the written examination for sending of a Supervising Officer from the Directorate along with question cum answer scripts.

5. Checking of names and documents before issue of Admit Card under supervision of Deputy District Land & Land Reforms Officer. Issue of Admit Cards to the Candidates and General Notification regarding the Venue, Syllabus and Production of Testimonials and Photographs.

6. Intimation to the O.C. of the Police Station for security arrangement and order to the Invigilating Officers and staff for checking documents.

7. a) Preparatory work at the venue; b) Selection of Invigilators from SRO-IIs and ROs and c) Holding of Examinations.

8. Coding of Roll Nos., evaluation of Answer Sheets, Tallying of marks, Tabulation of marks and decoding of Roll Nos., publication of results.

9. Return of used and unused question papers, furnishing of proceedings regarding the examination.

- 10. Type Test for the candidates of L.D.C. post and publication of final merit list.
- 11. Issue of PVR and Medical Examination Forms to the successful candidates.
- 12. Issue of Appointment Letters and updation of registers of reservation.

# 1.0 Clearance of vacancies

The final vacancy position regarding recruitment will be intimated shortly to all the DL & LROs as Appointing Authorities. DL&LROs should then immediately take up with the Dy. Director, Employment or the Officer-in-Charge of the Employment Exchange at the District Head Quarters for sponsoring of candidates from all the Employment Exchange Offices under the District Employment Officer.

# 2.0 Notification of vacancies to the Employment Exchanges

As per the West Bengal Regulation of Recruitment in State Government Establishment of Public undertaking, Statutory Bodies, Government Companies and Local Authorities Act, 1999 all recruitment shall be made through the Employment Exchange without fail. Hence the prescribed requisition form giving (See **Annexure –A**) the detailed information should be filled up and sent to all the Employment Exchanges in your district for wide circulation. A copy of the recruitment rules should also be sent to clear any doubts.

# 3.0 Sponsoring of candidates

It should be ensured through constant contact that the Employment Exchange Officers respond satisfactorily. No region in a district should be left out because it would lead to under representation of an area/ region, later on. It has been decided that sponsoring of candidates shall be made @ 25 candidates for every vacancy. For Amins and B.S. 30 days should sufficient for sponsoring of candidates but in case of LDCs they may take upto 45 days.

# 4.0 Intimation to the Directorate

Presently only the setting of question papers shall be done from the Directorate level and the remaining issues are decentralized to the districts. However, the DL&LRO should ascertain the possibility of obtaining sufficient venues well in advance and after receipt of the names of the sponsored candidates, he should intimate the date to the Directorate at least three weeks ahead. Directorate shall also depute a supervisory officer to act as an observer.

# 5.0 Checking of names and documents and issue of Admit Cards etc.

There shall be a proper checking of all names and all supporting documents received from Employment Exchanges by a checking team headed by Deputy DL & LRO. For every candidate a letter shall be sent enclosing a blank Admit Card with some instructions. Two copies of photographs should be sought for and they should always be attested. One copy should be pasted on the Admit Card and another copy should be preserved in the office file. A sample is given as <u>Annexure "B"</u> Roll No. should be given based on the category to which the candidate belongs such as Ex: Gen-55, SC-71, ST-25, X-Serviceman-42, P.H.-22, Department-44, OBC-21 etc.

# 6.0 Intimation to the O/C, Police Station

For proper security arrangement and to face any untoward incidents during conduct of the Examination, the Officer-in-Charge of the local Police Station should be informed well ahead to arrange for deployment of Police personnel on the Examination Day. (A sample is given at **Annexure-C**).

# 7.0 Preparatory Steps for the conduct of Examination

It should be ensured that all the venues and the rooms are thoroughly checked as to their suitability in advance. The rooms should have adequate furniture and should have sufficient daylight. As only two candidates can be located at either end of a table/high bench. The actual seating capacity should be properly estimated. All venues should be located at the District Headquarter itself and should not be shifted to the mufassil. Usually educational institutions are selected due to their better suitability. Prior to the date of the examination, proper arrangement for the pasting of Roll Nos. on the tables, directions to the rooms as per roll nos., seating arrangement for staff to check the testimonials, etc. at each venue should be made. Arrangements for drinking water are to be made at each venue. It should also be ensured that there are privy and sanitary arrangements at the venue. A general

notification regarding the conduct of the examination should be issued also (A sample is given at **Annexure D**).

An order shall be issued appointing invigilators (A sample is given at <u>Annexure E</u>). Officers in the rank of Revenue Officers and SRO-IIs shall be appointed. No officer shall be appointed as Invigilators whose son/daughter or relatives are sitting for Exams. Each venue shall have a senior officer like Dy. DL LRO, SDL&LRO as Officer-in-Charge to ensure that the conduct of the examination takes place smoothly and that on untoward incident takes place and to prevent any form of copying or unfair practices. They shall also brief all invigilators regarding the conduct of the examination and prevention of unfair practices compulsorily. There shall be one invigilator per 30 candidates. All used and unused question papers shall be collected and sealed. The invigilators should ensure that the candidates sign the attendance sheet, and they should ensure that the candidate's image tallies with that of the admit card and also initial every question cum answer script. After the completion of the examination, a brief proceeding be prepared and sent by the DL&LRO to the DLR&S, WB, (A sample is given at **Annexure F**).

The duration of the Examination is 1 and  $\frac{1}{2}$  hours. Question-cum-answer scripts should be distributed to the candidates 5 minutes ahead of the scheduled time of starting. No candidates shall be allowed to enter into the Exam. Hall after 15 minutes of the commencement of Exam. No candidate shall be allowed to go out of Exam. Hall during 1 and  $\frac{1}{2}$  hours of duration of the Exam. Similarly, no candidate shall be allowed to leave the hall before the end of the Exam. No candidate shall be allowed to leave the hall before the end of the Exam. No candidate shall be allowed to leave the hall before the end of the Exam. # 8.0 Evaluation of Question-cum-Answer scripts

After the checking and verification of all question-cum-answer scripts in comparison with the attendance sheets at each venue, they shall be brought to a central location for an on-the-spot evaluation. It should be ensured that the candidate writes his name and roll no. on the space provided in the first page of the question cum answer script only and nowhere else and the back side of the first page shall be left blank.

Coding of question cum answer scripts shall be done centrally and by one officer under the supervision of the observer from the Directorate. The portion of the 1<sup>st</sup> page having the name and roll no. shall be removed and a code no. shall be given on the question cum answer script. To ensure that no mistake is made the code no. will be also written on the top position of the question cum answer script and all these papers shall be preserved.

Evaluation shall be done by a group of selected officers continuously until the process is completed. A key answer script shall be provided to facilitate the process.

After evaluation the totalling of all marks received and tabulation as per the marks received for each candidate identified by the code no. shall be made. The mark-sheet tabulation sheet be sent to the Directorate through the observer under sealed cover for approval before publication. Depending on the number of vacancies the number of qualified candidates would be selected in order of merit starting from the highest marks received on a 1:1 ratio for each category. There is separate minimum qualifying mark for each category. In the case of LDCs they shall have to be asked to appear for a type test. Before the publication and display of the marks on the Notice Board the decoding of only those candidates selected shall be made.

## 9.0 Despatch of unused / used questions papers and other items

It is the responsibility of the DL & LRO to ensure that each question cum answer script received and issued to candidates is collected and accounted for. The used/unused question papers should be separately bundled and sent to the Dte. along with the proceedings of the examination, through the observer of the Directorate.

## 10.0 Type Test for LDCs

A type test on a passage having 300 words shall be selected for a type test to be completed in 10 minutes. Candidates will be given a grace of 5% of the words total typed to be set off against the number of mistakes made. As per Recruitment Rules, the minimum qualifying speed would be 30 correct words per minute. A candidate found qualified in written test but disqualified in Type test will not be treated as "successful" in the final merit list to be published.

# 11.0 Issue of PVR and Medical Exam.

On receipt of the merit list duly approved by the Dte., DL&LRO will issue PVR and Medical Exam. Forms to the finally selected candidates by observing existing formalities.

### 12.0 **Issue of Appointment Letters**

On receipt of the PVR from the authority and Medical reports from the Competent Authority appointment letters shall be issued by the DL & LRO. The Register of Reservation should be updated and the candidates should be asked to join within 30 days. After they join, their Employment Exchange Cards should be seized and sent back to the Employment Exchange for record. The Directorate, should also be intimated the names of the candidates appointed finally and the category to which they belong.

- a) Must be a Citizen of India or such other nationalities as are declared eligible by Government of India;
- b) Must have passed the Madhyamik Examination of West Bengal Board of Secondary Education or its equivalent;
- c) Must have basic knowledge of computer operation to be supported by a Certificate from any recognized Institute/ Institute of repute;
- d) Must have ability to transcribe at the rate of 30 words per minute to be tested by the Commission under Rule 6 of this rules.
- e) Must have ability to read, write and speak in Bengali (Not required for recruitment in the case of Nepali speaking candidates from hill areas of the District of Darjeeling);
- 05. <u>Age</u> :-

Not less than 18 years and not more than 30 years on the 1<sup>st</sup> day of January of the year of the advertisement subject to the condition that the provisions of the West Bengal Services (Raising of Age limit) Rules 1981, as amended from time to time, shall apply so long as the said rules shall remain in force. #### **MEMORANDUM**

A scheme for absorption of the Tahasil Mohurriors in regular establishment against available vacancies in Group D posts in phases has been under active consideration of the Government. After careful consideration it has been decided that all cases of absorption of the eligible Tahasil Mohurriors may be considered in the same manner as has been done in the identical cases of absorption of the Tahasil Mohurriors in compliance of the various orders of the Hon'ble High Court, subject to the terms and conditions detailed below.

2. (i) A very careful scrutiny ought to be made with reference to available papers i.e. acquittance rolls etc. and other corroborative records before entertaining the claim of the incumbents serving as Tahasil Mohurriors for the purpose of absorption.

(ii) After ascertaining the genuineness of the claim of the incumbents for absorption, a list of eligible candidates should be prepared with particular reference to their date of appointment, length of service, continuity in service etc. i.e. length of service should be the basic criterion and the names of candidates to be arranged in accordance with the date of engagement read with order dated 29.9.93 of His Lordship Mr. Justice Gitesh Ranjan Bhattacharyya in Civil Rule No.7592(W) of 1991.

(iii) Provisions laid down in Labour Department's Circular No.1700-EMP dated 3.8.79, which were operative at the material time, shall also be taken into account.

(iv) A reasoned order should be passed in all individual cases where the District Land and Land Reforms Officer concerned, decides against absorption of incumbents on account of their ineligibility to avert unnecessary litigation.

(v) No "Group-D" post shall be filled up from outside, except in "(die-in-harness" or similar nature) "Exempted Category" cases, till all eligible Tahasil Mohurriors are absorbed, subject to availability of vacancies in Group "D" posts.

(vi) While implementing the decision of absorption of Tahasil Mohurriors excess age of the incumbents, if any, may be condoned by the concerned authority under the relevant rules of the Government and/or as directed by the Hon'ble High Court.

(vii) Seniority of the incumbents shall be determined in accordance with the determination of Seniority Rule, 1981. Past services rendered by them elsewhere in any capacity prior to absorption shall not be taken into account under any circumstances.

(viii) Government decision in respect of any matters, retiring benefits and any other benefits shall be binding upon the concerned personnel after their absorption under this Government.

(ix) An undertaking has to be obtained from each individual in respect of the conditions laid down in items (vii) and (viii) prepage before his absorption in Government service in order to avert any possible litigation in future.

(x) An undertaking has also to be obtained from each individual Tahasil Mohurriors, if absorbed, to he effect that the may be posted anywhere in the State in the interest of public service.

(xi) The absorption of the eligible Tahasil Mohurriors shall be subject to due observance of all formalities i.e. Medical fitness, Police verification etc. as are normally observed in case of appointment of personnel in Government service.

3. The list of eligible Tahasil Mohurriors already prepared in respect of each district in the office of the DLRS including those who are petitioners in various court cases (in accordance with the Courts order) should reach the respective District Land and Land Reforms Officer within 15.11.98 positively.

The said list should be exhibited in the Notices Board of the office of the District Land and Land Reforms Officer concerned for a period of 30 (thirty) days with effect from 1.12.98. The D.L.&L.R.O. should also publish a notice in the leading newspapers of the district. The notice should contain the stipulation that a person claiming himself to be an ex- Tahasil Mohurrior and his name not finding place in the list, may file a petition duly supported by documents to the concerned authority within 30 (thirty) days i.e, within 31.12.98. No petition after 31.12.98 in support of the claim of absorption as Tahasil Mohurrior will be accepted by the authority under any circumstances.

A Scheme for absorption of the eligible Tahasil Mohurriors in the regular establishment of this Department against available vacancies in the Group "D" post in phases was taken up for implementation, subject to certain terms and conditions stipulated in Land and Land Reforms Department Memo. No. 5670-GBIII dt. 15.10.98.

While ascertaining the eligibility of the Tahasil Mohurriors for absorption in the Group "D" post under the regular establishment, it has come to the notice of this Department, that a number of Tahasil Mohurriors were engaged below the minimum prescribed age of 18 years contrary to the provisions laid down in Finance Department Notification Nos. 8321-F dated 06.11.81 and 8322-F dated 06.11.81 for recruitment to the Group "D" Post of Peon/Night Guards etc.

A question has now arisen as to whether the Tahasil Mohurriors who were engaged below the prescribed minimum age of 18 years will be eligible for recruitment/ absorption in the said posts under the regular establishment of this Department.

After careful consideration, it has been decided that for the purpose of absorption of the Tahasil Mohurriors to the Group 'D' posts under the regular establishment of this Department, the provision laid down in Finance Department Notification Nos. 8321-F dated 06.11.81 and 8322-F dated 06.11.81 and also the provisions laid down in para 5 in Labour Department Memo No.1700-EMP dt. 3.8.79 shall apply mutatis mutandis in these cases. The incumbent who were engaged as Tahasil Mohurriors on commission basis below the minimum age of 18 years and has not worked for five consecutive years after attainting the age of 18 years shall be debarred from consideration for absorption in group "D" posts under the regular establishment of this Department even if they are otherwise found eligible.

It must be ensured that the above guideline and circular are strictly followed for absorption of Tahasil Mohurriors.

Sub : Guidelines for recruitment of Gr. 'D' (Clerical) employees on contract basis.

In inviting reference to the correspondence resting with his memo No.1183/Estt. dt. 04/06/2002 on the above subject, the undersigned is directed to convey hereby the following guidelines for recruitment of Gr. "D" (Clerical) employees on contract basis :-

i) The appointment on contract basis should be made in strict adherence to the principle of 100 point Roster.

ii) Only candidates sponsored by the Employment Exchanges should be considered for appointment.

iii) No candidate should be selected on the basis of open market advertisement in addition to candidates sponsored by Employment Exchanges.

iv) The appointments should be made on contract basis for a period of one year only with scope for renewal .

v) The candidates thus selected for appointment would be entitled to the minimum of the pay scale of post without any allowances. Their leave will be guided by rule 213 of WBSR Pt. I.
