**NOTIFICATION**

No. Estt/2850/2M-36/64 dt. 22<sup>nd</sup> June, 1964- In exercise of the powers conferred by the proviso to article 309 read with Article 313 of the Constitution of India and in supersession of all previous notifications on the subject, the Governor is pleased to make the following rules regarding the conditions of medical attendance and treatment of all Government servants serving the State of West Bengal excepting those who are governed by the Secretary of State Services (Medical Attendance) Rules 1938 and the All India Services (Medical Attendance) Rules 1954.

**RULES**

**Part - I**

**1.** Short title and application :

(1) These rules may be called the West Bengal Services (Medical Attendance) Rules, 1964. They shall come into force on the 1<sup>st</sup> July, 1964.

(2) They shall apply to all persons in the whole time service of the Government of West Bengal including their families excepting those who are governed by the Secretary of State's Service (Medical Attendance) Rules, 1954.

These rules shall be applicable to the Government Servants and their families when such Government servants are on duty, on leave or under suspension, but shall not apply to :

(a) Those Government servants who are outside India on leave or deputation.

Provided that such members of the families of such Government servants as do not accompany them shall continue to be governed by these rules.

(b) retired Government servants;

(c) deleted;

(d) Government Servants on foreign service or on deputation unless specially authorized;

**2.** Definitions : In these rules, unless there is anything repugnant in the subject or context,

(a) authorized medical attendant means -

(i) in respect of Gazetted Officers posted in Calcutta, any Presidency Surgeon,

(ii) in respect of non-gazetted employees posted in Calcutta, the medical officer of any Govt. staff Dispensary in Calcutta.

(iii) in respect of Gazetted Officer, irrespective of their pay, and non-gazetted employees drawing pay of Rs. 250/- per month and above posted outside Calcutta, the Chief Medical Officer of Health, the District Medical Officer, the Sub-divisional Medical Officer and the Special Medical Officer attached to a Government Hospital or dispensary,

(iv) in respect of non-gazette employees posted outside Calcutta and drawing pay of less than Rs. 250/- per month, any medical officer of a Government Hospital or of a Health Centre and in case of emergency the Chief Medical Officer or Health.

- (b) "Family" means the wife or husband, legitimate children (including step children) and parents of a Government servant wholly dependent on the Government servant.

Provided that a parent whose income exceeds Rs. 250/- per month shall not be considered as wholly dependant on the Government servant.

- (c) "Government" means the Government of West Bengal.
- (d) "Government Hospital" means a hospital, Health Centre, dispensary or clinic other than afternoon pay clinic managed wholly by Government and includes the Carmichael Hospital for Tropical Diseases attached to the School of Tropical Medicine, Calcutta and
- (d) "Government servant" means a person in the whole time employ of the Government of West Bengal either in a permanent or a temporary capacity, but does not include part-time or honorary workers.
- (e) omitted.
- (f) "Medical Attendance" means attendance for professional advice normally in a Government hospital,
- (g) "Nurse" means a registered nurse;
- (h) "Patient" means a Government Servant or a member of his family who is sick or who needs medical or surgical service for confinement.
- (i) "treatment" means the use of medical and surgical facilities (i) at a Government Hospital in which a patient is treated (ii) at the consulting room of the authorized medical attendant or (iii) when the patient is too ill to travel, at the residence of the Government Servant and includes;
- (i) the employment of such pathological, bacteriological, radiological or other methods as are considered necessary by the authorized medical attendant.
- (ii) the use in accordance with provisions in sub-rule (2) of Rule 4 of such medicines, vaccination, sera or other therapeutic substances as may be considered necessary by the authorized medical attendance,
- (iii) medical and surgical services at confinement,
- (iv) dental treatment,
- (v) accommodation in Hospital suited to the status of the Government servant, it being competent for Government to notify from time to time the classes of accommodation that are suitable for Government servants of various categories for the purpose of these rules;
- (vi) such nursing as is ordinarily provided at the Hospital or such special nursing at the Hospital as the authorized medical attendant at the Hospital may certify in writing to be essential for the recovery or for the prevention of a serious deterioration in the condition of the patient, having regard to the nature of the disease but does not include provisions of dentnues, artificial eye, spectacles, hearing aids or artificial limbs except provided hereinafter,

**Explanation :** In sub-clause (vi) special nursing means employment, for treatment in a Government Hospital, of the services of private nurses from outside over and above the nursing ordinarily provided at such Hospital. \*1

**3. Facilities for medical attendance :**

(1) Medical attendance will be provide to a Government Servant free of charge in Government Hospital.

(2) Deleted.

**4. Facilities for treatment:**

(1) Except as provided in sub-rule (3) a Government servant shall be entitled to indoor and outdoor treatment in a Government Hospital free of charge; and if he receives treatment as indoor patient he will also be entitled to free accommodation suitable to his status referred to sub-clause (v) of clause (i) of Rule 2, provided such indoor treatment is certified to be necessary by the authorized medical

attendant. He will be entitled to receive all facilities which are available to indoor patients in the Hospital free of cost. He will also be entitled to receive free of cost all such facilities including facilities for pathological, bacteriological, radiological, biochemical and other examinations, blood transfusion, delivery and surgical operation as may be considered essential.

(2) All medicines, vaccines, sera etc. required for the treatment of the Government servant will be supplied free of charge by the Government Hospital where treatment is received, provided that such medicines, vaccines, sera etc. are available in the Hospital stock.

(3) The entire cost of special nursing or of special attendant or aya or of both shall initially be borne by the Government servant but such Government servant shall be entitled to reimbursement of the same on production of documents prescribed in sub-rule (2) of Rule 10.

(4) Expenditure incurred during indoor treatment for purchase of such medicines as are not available in the stock of the Government Hospital where treatment is received and as are certified to be essentially necessary by authorized medical attendant shall be reimbursed to the Government servant upto a maximum of Rupees two hundred only on each occasion of indoor treatment, provided the prescribed items are not included in the list made by Government from time to time of the medicines and other therapeutic substances which will not be admissible for the purpose of reimbursement to the Government servant and shall not be extended to the members of their families.

**6. Medical attendance and treatment of families of a Government servants :**

The members of the family of a Government servant shall be entitled to facilities for medical attendance and treatment similar to those allowed to the Government servant himself under these rules, subject to the limitations provided in Rule 7.

After Rule 6, insert the following rules, namely :

**6A. Special provision regarding continuance of certain facilities :**

In addition to the benefits provided for elsewhere in those rules, Government servants, both gazetted and non-gazetted, specified in column 1 of the table below shall enjoy the facilities of free advice and treatment from Government Medical Officers, including Presidency Surgeons, specified in the corresponding entries in column 2 of that table in the manner and under the circumstances laid down in Notification no. Medi/5090/7M-9/52 dated the 25<sup>th</sup> October, 1952 read with Notification no. Medi/5091/7M-9/52 dated the 25<sup>th</sup> October, 1952.

**6B. Special provisions regarding medical attendance and treatment of Government servants in case of injuries.**

All Government servants shall, in case of their being injured in the course of performance of their official duties, be entitled to the following facilities of medical attendance and treatment in addition to those provided for elsewhere in these rules :

(1) When attacked and injured in the execution of their duties or on account of their official position during civil disturbances or otherwise :

Free medical treatment as provided in Rule 7 of Part – I read with Rule 5 of Part – II of the Rules promulgated under Notification No. Med1/5090/7M-9/52 dt. 25<sup>th</sup> October, 1952.

(2) When injured or otherwise sick as a result of their being involved in any accident in the performance of their official duties, whether within or outside the State of West Bengal.

Medical attendance and treatment as admissible under the West Bengal Services (Medical Attendance and Treatment of Injury) Rules 1954 prescribed in Notification No. Med1/9496/7M-26/54 dated the 24<sup>th</sup> December, 1954.”

**7.** Special provisions regarding supply of spectacle.

Expenditure incurred for the purchase of spectacles by Government servants drawing a basic pay upto Rs.825/- per month will be admissible for reimbursement upto a maximum of rupees forty only per pair of spectacles, subject to a limit of one pair of spectacles in five years. This privilege will be confined only to the Government servants and shall not be extended to the members of their families.

**9.** Duties of a Government Hospital Authority.

When a Government servant requiring medical attendance or treatment approaches a Government Hospital and establishes his identity, he shall be given all facilities for attendance and treatment as are permissible, to admit a Government servant to indoor beds when such admission is considered necessary by the Medical Officer of the Hospital, and after all necessary treatment has been completed such certificates as may be necessary shall be given to the Government servants free of charge over the signature of the Medical Officer in charge of treatment with seal of his office.

**10(1)** Omitted.

(2) All claims for reimbursement admissible under sub-rule (2) of Rule 4 and Rule 7 shall be made in the prescribed form supported by records and vouchers or cash memos, as the case may, showing payments made by the Government servant and such certificates as may be prescribed by Government from time to time. The claims shall be preferred by the Government servant to the Head of the Office where he is employed, unless he himself is the Head of the Office. The Head of the Office, after initial scrutiny, shall send the bill to the Controlling Officer concerned. Similarly in respect of any claim of a Government servant who is himself the head of an office, the bill shall be submitted by him to the officer, who is empowered to countersign his traveling allowance bills unless he is a self countersigning officer.

(3) It shall be the duty of the Controlling Officer to scrutinize carefully, before signing or counter signing a claim in respect of medical expenses, to ensure that the claim is genuine and is covered by the Rules and Orders in force and that the charges claimed are supported by the necessary document. The Controlling Officer is empowered to disallow claims which do not satisfy these conditions.

(4) The charges on account of medical expenses payable to Govt. servants shall be adjusted under the following primary and detailed units subordinate to the respective major, minor and sub-heads :

(a) Under “Contract Contingencies” “Contingencies” or “Other Contingencies”, as the case may be, in respect of Government servants when pay and allowances are met from contingencies.

(b) Under “Allowances, honoraria, etc.: House rent and other Allowances” in respect of other Government servants.

**ORDER**

In partial modification of this Directorate order No. HPA/G-409-81/KW/192-P dt. 7.5.82, the rate of remuneration of Special Attendants is re-fixed at the rate of Rs. 16/- (Rupees Sixteen) only per short of 12 hours in all the hospitals located in Calcutta.

This order will take effect from 16<sup>th</sup> May, 1985.

2. It is further ordered that one Special Attendant will attend not more than one patient at a time.
3. Patients occupying free beds will not ordinarily be permitted to engage Special Attendants. However this may be permitted on the basis of a formal application by the patient or his relations, such application having been recommended by the Physician/Surgeon in charge of the bed, and approved by the Superintendent who shall have to satisfy himself of the urgent need for engaging a Special Attendant.
4. All heads of the institutions should ensure that no patient is compelled to pay rates higher than the prescribed ones. Any deviation from this order should be firmly dealt with and may result in being struck off the rolls.

In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor is pleased hereby to make, with effect from the 1<sup>st</sup> January, 1988, the following amendments in the West Bengal Services (Medical Attendance) Rules, 1964, published with this Department Notification No. Estt/2860/2M-36/64 dated the 22<sup>nd</sup> June, 1964, at pages 1933 to 1939 of Part I of the Calcutta Gazette. Extraordinary dated the 25<sup>th</sup> June, 1964, as subsequently amended (hereinafter referred to as the said rules):-

**AMENDMENTS**

In the said rules-

- (1) In the proviso to clause (b) of rule 2, for the letters and figures "Rs. 250" substitute the letters and figures "Rs. 500";
- (2) In rule 4
  - (i) For the words "up to a maximum of rupees two hundred only" substitute the words "as well as the members of his family upto a maximum of rupees four hundred only" and
  - (ii) Omit the last sentence beginning with the words "This privilege" and ending with the words "their families" ;
- (3) In rule - 7
  - (i) for the letters and figures "Rs.825/-" substitute the letters and figure "Rs. 1500/-"

(ii) for the words "Rupees forty only" substitute the words "Rupees seventy-five only".
