No. 516-CI/O/MIN/GEN-MIS/02/2015 (Pt.-II).—7th September, 2016.—Whereas, the Govt. of West Bengal has notified and published the West Bengal Minor Minerals Concession Rules, 2016 (hereinafter rules) in repealment of West Bengal Minor Minerals Rules, 2002 for introduction of the transparent regime of competitive bidding including the e-bidding for parting with the mineral right of the minor minerals within the State of West Bengal and other ancillary matters;

And, whereas, it is expedient in the public interest to clarify the minimum area as prescribed in rule 6 of the rules in view of the Notification No. S.O 141(E) dated 15th January, 2016 of the Ministry of Environment Forest and Climate Change, Government of India(hereinafter MoEF&CC);

Now therefore, in exercise of the power conferred in rule 60 of the rules the Governor is pleased hereby to order that the minimum area for mining lease of minor minerals shall be such area as to be prescribed by the MoEF&CC as the minimum area eligible for obtaining Environmental Clearance from time to time.

No-597-CI/O/MIN/GEN-RLT/02/2015.—22nd September, 2016.—In exercise of the powers conferred by clause (g) of sub-section (1A) of Section 15 of Mines and Minerals (Development and Regulation) Act, 1957 (67 of 1957) and sub-rule (1) of rule 35 of the West Bengal Minor Mineral Concession Rules, 2016, the State Government hereby prescribes the interim rates of royalty and dead rents on the basis of Notification No.422-CI/O/MINES RULE/002/02/MI dated 8th November, 2002 (since repealed) for minor minerals as follows:-

- 2. These rates shall remain in force till further Notification in this regard.
- 3. For the re-classified minor minerals [vide Notification No. GSR 423(E) dated 10th February, 2015 of the Ministry of Mines, Govt. of India] the last rates of royalty and dead rents as prescribed by the Indian Bureau of Mines, Govt. of India shall prevail until further Notification in this regard.

This Notification shall come into force on and from 29th July, 2016.
