Subject : Reconstitution of Block Level Land Reforms Advisory Committees – Principles for distribution of vested and khas lands.

A reference is invited to Board's Memo. No.6437 (15)-G.E., dated 30th March 1972, intimating dissolution of the Block Level Land Reforms Advisory Committees constituted under Board's Order No.18897(15)/GE, dated 13th December, 1971.

It has since been decided that the Block Level Land Reforms Advisory Committees should be constituted as follows: -

- 1. The Local M.L.A. or his representative, Member,
- 2. Two representatives of the Political Parties recognized by the Election Commission [not more than one from each Political Party, which offered candidate in the last General Election held in March 1972, in the area concerned on the basis of the largest number of votes secured], Members,
- 3. Block Development Officer, Member,
- 4. Junior Land Reforms Officer, Convernor Secretary.

Besides, the State Government shall have powers of nominating members not more than four in number of which one must be of the eligible category of receiving land to represent special interest, if any, to the Advisory Committee.

While making settlement of the vested or khas land of a particular Anchal, the Anchal Pradhan should also be associated as a member of the Advisory Committee. Similarly, the Adhyaksha of Gram Sabha should function as a member of the Committee while settlement of land in his area is considered.

2. Any three members of the Committee of which the Junior Land Reforms Officer must be one, will form the quorum. Minutes of the proceedings of the meetings of the Committee should be properly kept.

3. For every meeting the members of the Block Level Land Reforms Advisory Committee will elect its own Chairman from amongst the members present.

4. With the object of distribution of vested and khas land from time to time the Junior Land Reforms Officer shall maintain lists of landless and land-poor peasants and shall place the report of verification and enquiries made by the Land Reforms Staff in this regard before the abovementioned Advisory Committee for approval in regard to –

(i) Distribution of vested or khas lands to eligible persons,

(ii) Regularization of occupation of vested or khas lands held by eligible persons.

Agenda of the meeting, the particulars of land to be distributed as also the list of eligible cultivators should be communicated to each member of the Committee at least one week before the date of the meeting.

If any person has any grievance in respect of the list prepared by the Land Reforms Staff, he may apply for redress to the Advisory Committee and the Committee after making such enquiries, as it may deem necessary, shall settle the matter. 5. Instead of granting license on year to year basis permanent raiyati settlement shall be given. Such raiyati settlement should be given straightaway by executing the "Deed of Settlement" in Form 8A as prescribed in the West Bengal Land Reforms Rules in terms of instructions contained in Board's Memo. No.8700(15)-G.E., dated 21st May, 1971, read with Memo. No.8718(15)-G.E., dated 27th May, 1971.

 $\,$ 6. In this context the principles for distribution of vested or khas lands are enunciated below: -

(i) Normally persons holding licenses for more than one year and cultivating the land themselves or by the members of their family may be considered as eligible and permanent raiyati settlement may be given to such persons. But in case where the previous licensees who might also have been eligible cultivators were displaced from cultivation by new licensees, the cases should be put up before the newly constituted Advisory Committees who should decide the claims on grounds of equity and give raiyati settlement to one or other or divide the land between them as the Committee thinks best in the circumstances.

(ii) As regards khas and vested agricultural land that have not yet been distributed on license basis or khas and vested agricultural land under unauthorized occupation of eligible cultivators which would require regularization and new lands that would vest in the State, the Junior Land Reforms Officer should place the details of such land before the newly constituted Advisory Committee for their consideration.

When the list of eligible cultivators together with the lands that would be allotted to them shall receive the approval of the said Advisory Committee, the Junior Land Reforms Officer shall take action for permanent raiyati settlement of the same in the manner indicated in paragraph 5 above.

7. The Advisory Committees will start functioning immediately as these are constituted in accordance with the principles laid down in paragraph 1. The political parties which are to send their representatives to the Committee should be requested by the District Officers to send the names of their representatives to the Junior Land Reforms Officers concerned within seven days of receipt of the intimation from the district authorities.

It may, however, be added that if any such Political Party or Parties do not send the names of representatives within the prescribed period, the Advisory Committee should be deemed to have been constituted and they should start functioning provided there is quorum. Names of the representatives sent later on should be included in the Committee.

- (vi) any overwriting or erasing in the minute should be signed by the Chairman of the meeting ;
- (vii) proceedings of the meeting should be written and completed immediately after the meeting and should be signed by the Chairman of the meeting before the members disperse, in any case the proceedings must invariably be signed by the Chairman and other members ;
- (viii) the Minute Book being a permanent record, it should be a bound volume and the papers should be of good quality ;
- (ix) after election of the Chairman of the meeting the minutes of the proceedings of the last meeting should be read over and confirmed and the fact of such reading over and confirmation should be noted in the Minute Book before the Committee proceeds to consider the other items of the agenda.

In the context of the provisions since made in the West Bengal Land Reforms Rules regarding consultation with the Land Reforms Advisory Committees for the purpose of settlement of khas and vested agricultural lands [vide Rule 20(A)(3a) of the Rules published under L.U. & R. and L. & L.R. Department notification no.1972-L. Ref., dated 21st January, 1975], the Board has been pleased to lay down the functions of the said Committees as follows :-

(i) to assist the officials in the preparation of eligibility list in their respective areas as envisaged under Board's memo. No.21654(17)-G.E., dated 9th November 1973, and to make recommendations for distribution of lands in conformity with the Rules and instructions laid down for the purpose;

(ii) to associate in the matter of conciliation of agrarian disputes especially arising in connection with sowing and harvesting of crops as between land owners and bargadars as also between any other rival claimants for the crops on the same land, etc.; and

 (iii) Such other matters as the Board of Revenue or the Government may from time to time specify.

2. It is in this connection enjoined that consultation with the Land Reforms Advisory Committees will not be necessary in cases of –

(i) distribution of homestead lands under the House-site Scheme, as provided for in Board's memo. No.3778(15)-G.E. dated 14th March 1975; and

 (ii) allotment of land to Military Personnel, as provided for in Board's memo. No.21913(8)-G.E. dated 13th October, 1972.

3. In the matter of finalisation of mouzawari eligibility lists prepared in terms of Board's memo. No.21654(17)-G.E., dated 9th November 1973, in consultation with the Land Reforms Advisory Committees, it is reiterated that such lists should invariably be submitted to the Subdivisional Officers for final approval. Only when the Subdivisional Officers feel any difficulty they will refer these to the A.D.Ms (L.R.) and not otherwise.

4. In the matter of settlement of land if the recommendation of the Land Reforms Advisory Committees is not based on the Rules and instructions issued for the purpose from time to time, the Collector or the Additional District Magistrate or the Subdivisional Officer shall refer the case to the Committee for reconsideration stating the reasons clearly. If even after reconsideration the Committee sticks to its previous recommendation and the Collector or the A.D.M. or the S.D.O., as the case may be, is not satisfied, he may disregard such recommendation and proceed to distribute the land on the basis of the eligibility list.

The Collector or the A.D.M. or the S.D.O. shall proceed to finalise the distribution programme where this could not be done for lack of quorum or otherwise in two successive meetings of the Land Reforms Advisory Committee.

5. For the purpose of distribution of vested lands at least one meeting of the Land Reforms Advisory Committee should be convened every month.

6. Nothing in these instructions shall prevent the Collector or the A.D.M. or the S.D.O. in taking such action as may be considered appropriate even in a matter which is normally referred to the Land Reforms Advisory Committees for advice or recommendations, where the Collector / A.D.M./ S.D.O. is of the opinion that immediate action is necessary in the interest of the exigencies of Administration.
