~~Subject: Payment of compensation to the unrecorded bargadars against acquisition of land.~~

~~It is to clarify that there is no distinction between recorded bargadar and unrecorded bargadar as per provision of WBLR Act, 1955. Whoever cultivates land of another person on condition of delivering a share of produce is a bargadar unless he is a relative of the land owner as per section 2(2) of the WBLR Act. It is, therefor, clear that a bargadar irrespective of whether his name is already recorded in the ROR or not, is entitled to get the compensation as per the provisions of section 23(4) of the LA Act, 1894.~~

~~If the unrecorded bargadar applies for compensation, his case will be considered provided he has applied before issuance of the notice under section 4(1) of West Bengal Land Acquisition Act. To be satisfied about the genuineness of a claim for getting compensation on account of bargs cultivation, it would be necessary to have a certificate from the revenue official of the concerned area. The matter may, therefore, be taken up with the ADM and District Land and Land Reforms Officer so that the concerned BL & LRO may enquire in the field and issue certificates in favour of the unrecorded bargadars who are found to be genuine as per field enquiry. A copy of this letter is being endorsed to the ADM and District Land and Land Reforms Officer, Hooghly for immediate necessary action.~~

~~Crash programme may be drawn up in the districts where such acquisitions are in process or likely to take place soon.~~

Since quite large area of land will be acquired by the Govt. for Industrial or other projects in near future in other districts too, the concerned ADMs may be suitably instructed to take up updation of records on a priority basis so as to reflect the current status of records by effecting all pending mutation cases, conversion cases and also by recording the cases of bargs cultivation so that the Collector may not face any problem in releasing compensation against acquisition of land in those districts. Primarily the districts to be affected are (1) North 24 Parganas, (ii) South 24 Parganas, (iii) Howrah, (iv) purba Medinipur, (v) Paschim Medinipur in addition to Hooghly.~~

~~WHEREAS with the prior approval of the Land & Land Reforms Department, Government of West Bengal, the West Bengal Pollution Control Board (hereinafter referred to as the 'Board') in its 117th meeting held on 19.12.2000 decided to declare and appoint the District Land & Land Reforms Officers of Government of West Bengal as ex-officio Environment Officers of the Board within their respective jurisdiction for the purpose of dealing with the matters relating to prevention and control of pollution from the Brick manufacturing Units:~~

My dear Asok,

During the last four years I have been writing to you many letters, some polite and some not so palatable. Now I am writing to bid farewell to all of you. I am leaving for Delhi on 16th January, 1982.

Often, in my letters I called upon you to do many things which apparently looked not so related to the core subject of land reforms. During these years I endeavoured to impress upon all my colleagues senior or junior that in an agrarian economy of ours land reforms is the key to rural development and that is why it has to be multi-dimensional both in its concept and implementation. Therefore, letters went on bank credit to sharecroppers and patta holders, new design of L.R.D.P. for the same group, Special component plan and Tribal Sub-plan for the beneficiaries of land reforms and the like. Land alienation, landlessness and insecurity of share cropping arrangement could be effectively combated not merely by a purely juristic approach but by multi-prong economic programme to bring the rural destitutes at least around or above the poverty line.

While one could take legitimate pride about the performance of 'Operation Barga', there is hardly anything to write home about the distribution of vested land. Restoration of land alienated through distress sale was also minimal.

I wouldn't venture to do a review of all that has been done or left undone during my tenure as Land Reforms Commissioner. To-day I would only like to express my heart-felt thanks for the cooperation that I received from you and from all your staff and officers in implementing operation barga and other schemes of land reforms.

There is a Chinese proverb that for a thousand 'lee' journey one has to take the first small step. What we have been doing is really a preliminary step towards the ultimate objective of rearranging the property structure in the agrarian sector to reduce poverty and to eliminate exploitation. We have miles to go.
