NOTIFICATION

No. 601-EN/1W-11/2015.—10th March, 2016.— In exercise of power conferred u/s 25 (2) of Water (Prevention & Control of Pollution) Act, 1974 read with West Bengal Prevention & Control of Water Pollution (Forms of Application for Consent of the State Board) Rules 1999 and u/s 21 (2) of the Air (Prevention & Control of Pollution) Act, 1981 read with Air (Prevention & Control of Pollution) Amendment Rules, 1999, as amended from time to time and the State Government in consultation with the West Bengal Pollution Control Board, hereby revises the consent application fees for all categories for "consent to establish" and "consent to operate" for all industrial units (Annexure I), Health Care units (Annexure 1 Table F), Housing/Commercial/Office Complexes including IT and infrastructural and Town Development Projects (Annexure 1 Table B), Local Bodies, Urban & Industrial townships (Annexure 1 Table C), Diesel Generator Sets for non-industrial use excepting Health care establishment (Annexure 1 Table D), Fire Works Manufacturing Units (Annexure 1 Table E), Ship Breaking Industries (Annexure 1 Table I).

In exercise of power conferred by Section 25 of The Environment (Protection) Act, 1986 read with of the Bio-Medical Waste (Management and Handling) Rules 1998 and the Hazardous Wastes (Management and Handling) Rules, 1989 as amended from time to time and the State Government in consultation with the West Bengal Pollution Control Board, hereby revises the fees for Authorization of Bio-Medical Waste for Health Care Establishments (Annexure 1 Table F), Authorization for operators under Bio-medical Waste (Annexure 1 Table G) and Authorization under Hazardous Wastes (Annexure 1 Table H), Authorization fees for handling and processing of Municipal Solid Waste (Annexure 1 Table J), Registration fees for Hazardous Waste recycling units (Annexure 1 Table K), Registration fees for Dealers of Lead Acid Storage Batteries (Annexure 1 Table L), Application fee for 'Consent to Establish' and 'Consent to Operate' for common Bio-medical Waste Treatment Facilities owned by the Government Institutions, non-profit organizations, Municipal Corporations and Municipalities (Annexure 1 Table M) and Authorization fees under E-Waste (Management & Handling) Rules, 2011 (Annexure 1 Table N).

This will take immediate effect.
