Sub: Perennial deprivation of departmental officers of the L.& L.R. Department being of the basic cadre of W.B.S.L.R.S. Grade-I - regards

Respected Madam,

The Association represents the cadres of W.B.S.L.R.S. Gr-I, S.R.O.-II and S.R.O.-I who are recruited to the basic post of Revenue officer via result of Gr. "C" of W.B.C.S.(Exe) & etc. Examination.

The Association has severally tried to meet and impress the highest authority of the State about the anomaly to which this cadre is ever subject in comparison to contemporary and equally placed officers of other department of the Government.

However, we depict the status pictographically again:-

W.B.S.L.R.S. Gr-I \rightarrow 1st Promotion (7-8 years) \rightarrow S.R.O.-II(functional post B.L.&L.R.O.) \rightarrow 2nd Promotion (20yrs from initial stage) \rightarrow S.R.O.-I (Scale No.14 of ROPA'98) (Scale No.15 of ROPA'98) (Scale No.16 ROPA'98)

Or

W.B.S.L.R.S. Gr-I \rightarrow 1st Promotion(7-8 yrs) \rightarrow S.R.O.-II(functional post B.L.&L.R.O.) \rightarrow 2nd Promotion(17yrs from initial stage) \rightarrow W.B.C.S.(Exe)(Scale No.14 of ROPA'98)(Scale No.15 of ROPA'98)(Scale No.16 & further being State Service)

Comparison with other comparable cadres in terms of the same mode of recruitment:

1st Promotion(7-8 yrs)enters State Service(a) Jt. B.D.O.----->W.B.C.S.(Exe.)----->Scale No.17 and beyond(Enters at scale 14 ROPA'98)(Scale No.16 ROPA' 98)

Now, on this backdrop, the Department also very recently initiated a number of files and proposals, often at the instance of the Highest Authority, highlighting the factum of deprivation against the stated grades of officers and always suggesting higher scales, more higher posts and culminating in the proposal for creation of State level Land Reforms Service comprising the Departmental Officers.
