

Sub: Pendency in respect of Rule formation of W.B.L.R.S. as also initiation of filling up backlog to W.B.C.S.(Exe) from the feeder cadre of S.R.O.-II- regards

Sir,

Please find enclosed the copy of letter from P.S.C., West Bengal which is self-explanatory. It is obvious that there are vacancies to the extent of 51 posts to the W.B.C.S.(Exe) cadre from the feeder cadre of S.R.O.-II till 2018. It is mention worthy that further 21 vacancies have accrued against 2019 quota ant the collateral feeder cadre of Jt. B.D.O.s have already availed that quota. Thus, at present and for periods before 2020 there are 72 vacancies from the feeder cadre of S.R.O.-II.

The Association representing the cadres of W.B.S.L.R.S. Gr-I, S.R.O.-II, S.R.O.-I, would take the occasion to again urge that these vacancies may immediately be filled up. There is absolutely no reason as to why the eligible and willing S.R.O.-IIs cannot avail the vacancies though as it stands they shall already be rendered junior to the commensurate promotes from other cadres and the scant career prospect would be further jeopardized. We strongly submit that the issue may be taken up immediately.

Also to add that vide Notification No.406/1E-02/2020-Apptt. Dated.11.02.2021 of L.&L.R. and R.R.&R. Department, West Bengal (copy enclosed), W.B.L.R.S. has been notified with eligible S.R.O.-IIs & S.R.O.-I. It is learnt as is also normal that the proposal from the Administrative Department(L&LR & RR&R dept.) is with P&AR Department and has not been furthered yet. In the meantime, since the date of notification also numbers of eligible officers are retiring without getting the benefit as appeared to them in the fag end of the career after long struggle of decades and of course with the due will of the Government. It is incidental to add that the P.&A.R. Department had elaborately studied the concept in previous files being 552-LRC& Pr. Secretary/2018 as also 1E-10/2017-Apptt and had categorically opined in favour of creation of State Service in the L.&L.R. Department accommodating the S.R.O.-IIs and S.R.O.-Is. The decision as crystallized vide

Notification as referred above had been conceptualized and agreed upon by the P&AR department already. Hence, in this respect, we would submit that the file be furthered so that the framing of Rules, etc. be completed and the fate of the officers unwilling to part with the department and serve the department may not be suspended in uncertainty for so long.
