Respected Madam,

The Association is the primary Association representing officers of the grades of W.B.S.L.R.S. Gr-I, S.R.O.-II & S.R.O.-I and the Association has /had ever observed the promptness of this Government in acknowledging the righteous cause and zealous execution of the same. The Association is/was particularly impressed when in the month of February, 2021, this Government primarily accorded approval and sanction to the long unfulfilled but logical demand of the Association towards creation of **West Bengal Land Reforms Service**. The Notification is enclosed for reference. As evident the **State Service** was already declared comprising eligible S.R.O.-II and S.R.O.-I and what remained was the fixation of modalities and for the same the Group of Secretaries was empowered. As learnt from reliable sources, the proposed structure and modalities has also been fixed by the Group of Secretaries quite some time back. But till date, we, being the beneficiaries, have not moved ahead to any extent as the modalities of the proposed **State Service** has not been officially published yet.

We would request your good office to be instrumental so that the officers of the department start getting the benefits of the proposed State Service structure; it is incidental to assert that since the primary notification more than 6 months have passed and regularly officers are retiring.
