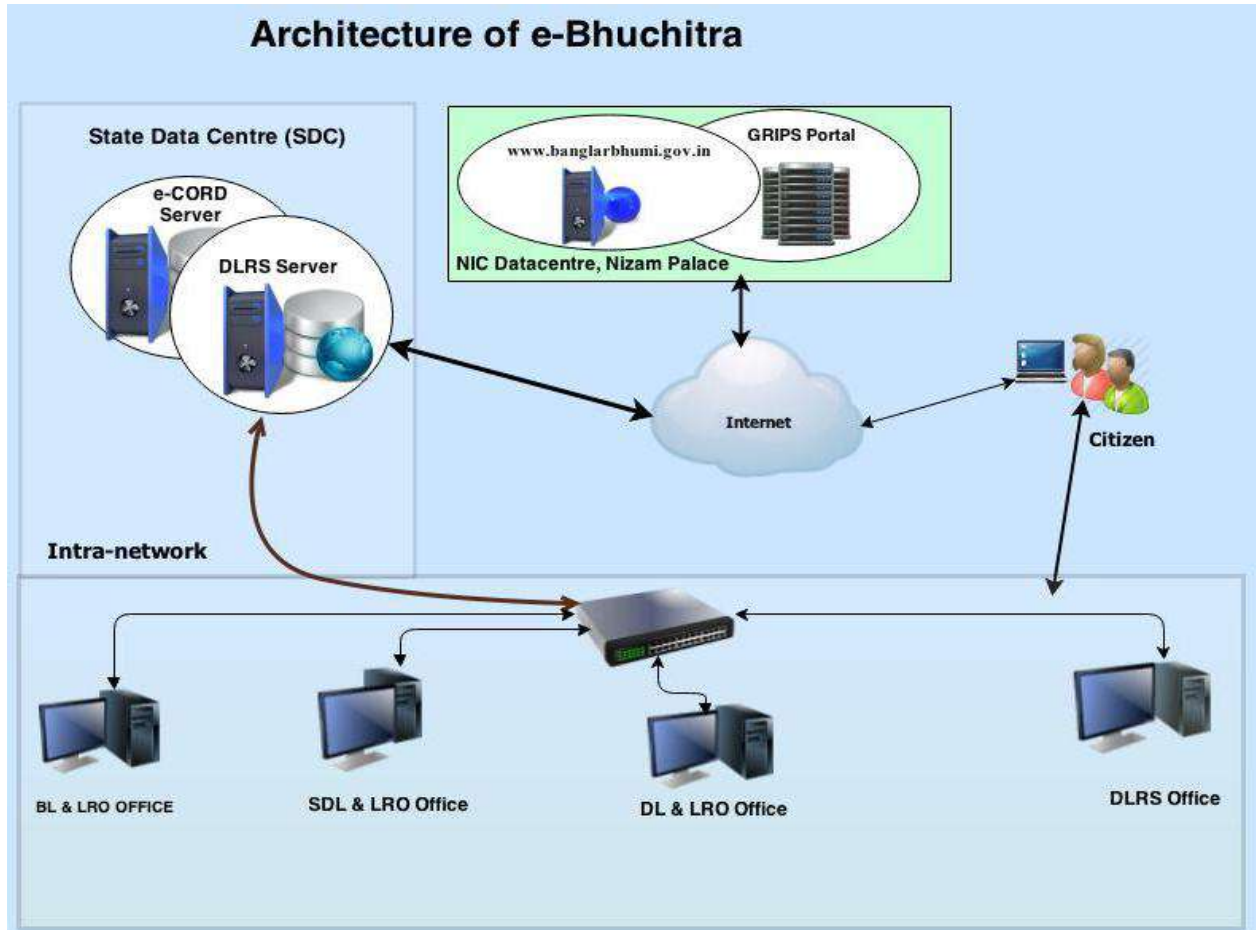

It manages day-to-day activities of 346 BLLRO offices in real time basis in a secured manner, and also integrated with registration offices for online mutation. It provides citizen centric services with respect to spatial and non-spatial data.

The **Land & Land Reforms Department, Government of West Bengal** is mainly responsible for the formulation of policies, Acts, Rules and procedures relating to land matters, namely, land records and survey, land revenue, land reforms, land use, management of government lands, requisition and acquisition of land as well as their implementation by way of preparation and revision of Records of right, including recording of share-croppers (bargadars); vesting and distribution of ceiling surplus land; determination of the requirement of land by tea gardens, factories etc.; mutation of ownership and conversion of classification of land; assessment and collection of land revenue and cesses; requisition and

acquisition of land administration of the Calcutta Thika and other Tenancies and Lands (Acquisition & Regulation) Act, 1981, the West Bengal Premises Tenancy Act, 1997, the West Bengal Public Demand Recovery, 1913 and other Acts.

5 About NIC

National Informatics Centre (NIC) was established in 1976, and has since emerged as a "prime builder" of e-Government / e-Governance applications up to the grassroots level as well as a promoter of digital opportunities for sustainable development. 8 MODULE DETAILS**8.1 Free Hold Title Deed****8.1.1 Primary Business Functions**

The influx of refugees from erstwhile East Pakistan (now Bangladesh) is a big phenomenon in Indian History. In consequence of partition of India in 1947, a large number of people were compelled to leave their homeland and come to India. From the very beginning of the exodus the primary task of the Government was to provide relief to the vast number of refugees. The Government has been trying to solve the Socio-economic problems arising from influx of refugee by undertaking various Relief and Rehabilitation measures. In order to tackle the massive task of providing relief and rehabilitation to millions of people, the Refugee Relief and Rehabilitation Department was created with offices at the District and Sub-Divisional level. The persons who migrated only from erstwhile East Pakistan (before 25.03.1971) are treated as REFUGEES by the RR & R Department (now R.R & R Section).

To solve the problem of displaced persons, the Govt. has set up some colonies, termed as Govt. Sponsored Colonies. Later the Govt. gave approval to the colonies, which were squatted upon by the refugees in large groups on blocks of private, Government and Semi-Governmental lands. These colonies are known as Squatters' Colonies which are categorized as – 149 group, 175 group, 607 group (these types are approved by Govt. of India) and 998 group (approved by the Govt. of West Bengal). Besides these types of colonies, there are Byananama Colonies and private Colonies under this department. The displaced persons residing only in the above mentioned colonies are considered for different rehabilitation measures taken by the department.

For settlement of Refugee Families, State Government has so far issued a considerable number of Free Hold Title Deed (FHTD). As per existing norms, such deed is conditional. Settled land cannot be transferred by the deed Holders within 10(ten) years from the date of issuance of such deed without permission from the State Government.

8.1.2 User Access Level

Any Block based user can do the application process
Modification can be done by those who entered the application in the system before case allotment. After case allotment the case can only be modified by the user who has been allotted to the case.

Case Allotment can be done by BLLRO user.

Tamil can be done by the user who has been allotted to the case.

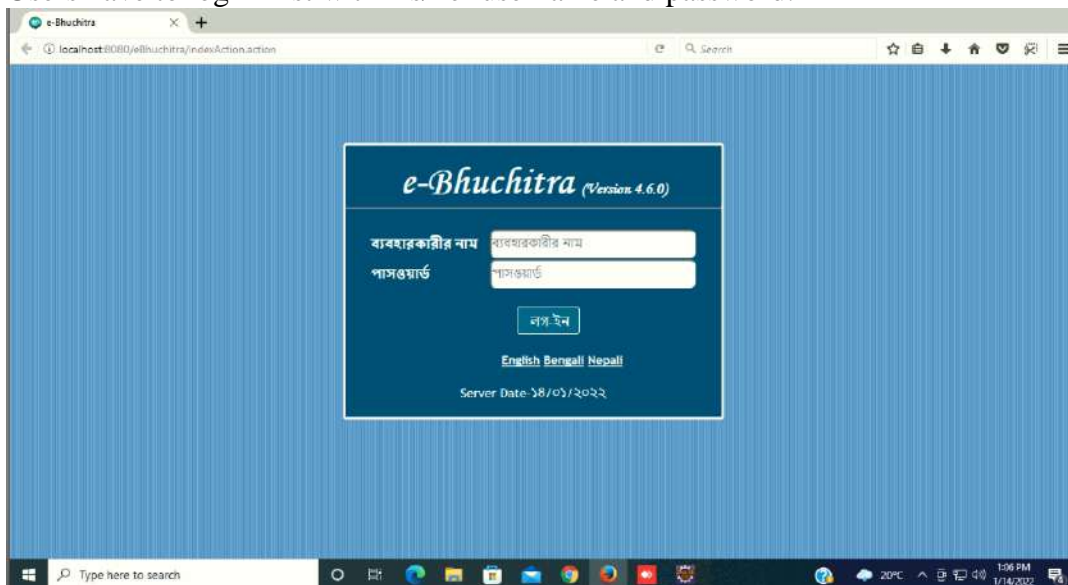

Users have to login first with his/her username and password.

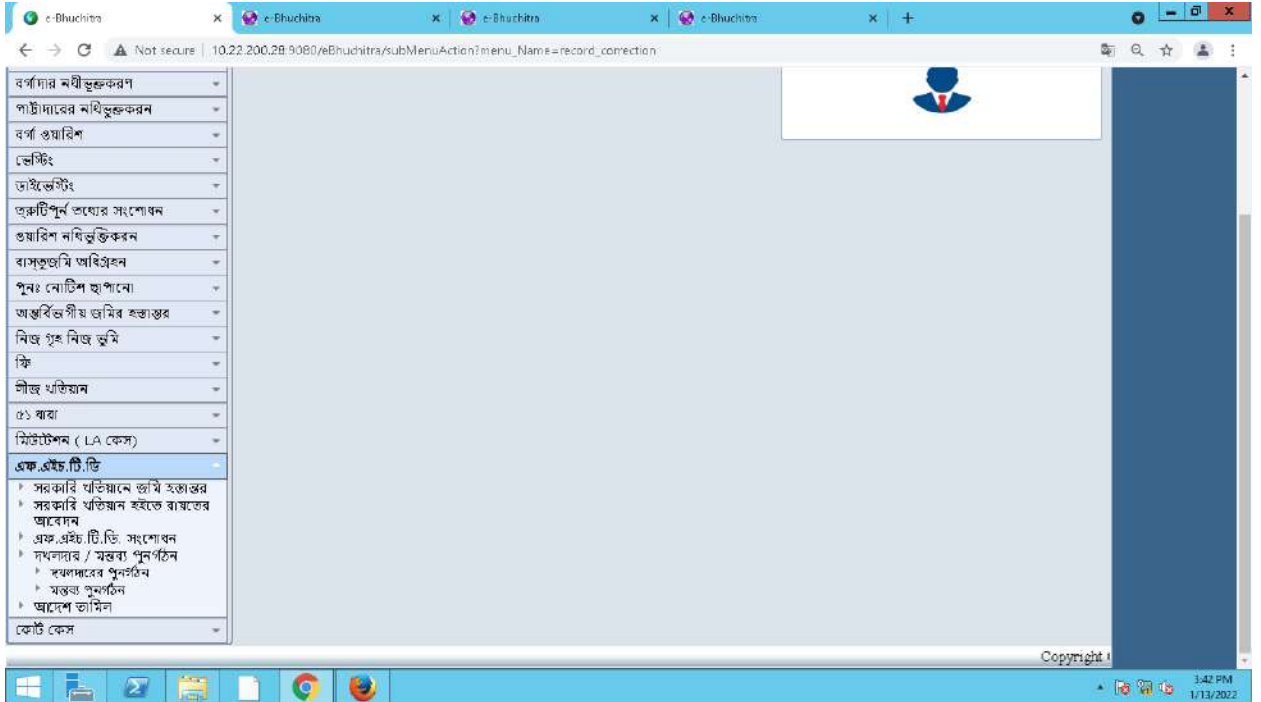


After successful login user will be forwarded to the below screen, which is the home page of this application. Here you have to select **রেকর্ড সংশোধন**.

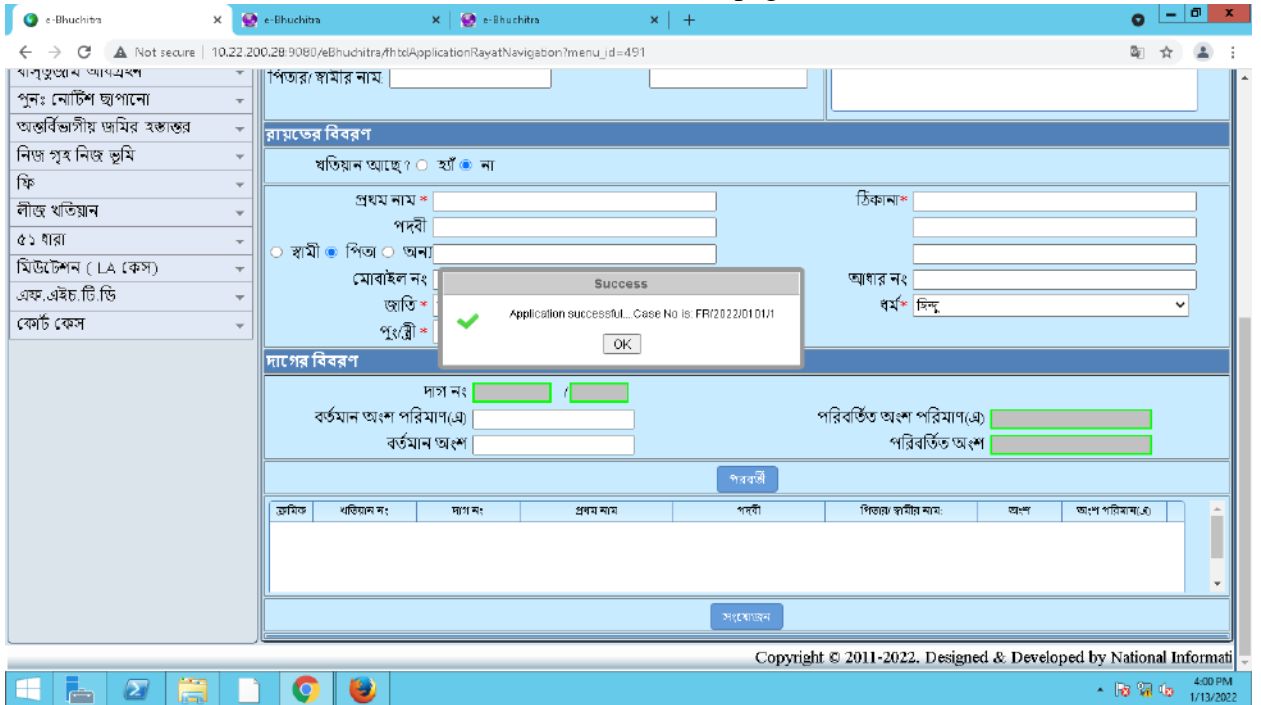
At the bottom, there is a "পরিবর্তী" (Update) button and a table for listing the khatian details.
