Now, the Governor is pleased to enlist the following case after the 17th case referred to in the TABLE above:-

xviii. Neuropsychiatric Disorders, that is to say:

- a) Bipolar Affective Disorder
- b) Major Depressive Disorder (MDD)
- c) Schizophrenia
- d) Obsessive-Compulsive Disorder (OCD)
- e) Autism Spectrum Disorder (ASD)
- f) Hyper Kinetic Disorder (Attention-Deficit Hyperactivity Disorder -ADHD)

The cost of medications in respect of the Neuropsychiatric Disorders mentioned under Para (a) to (f) above shall be reimbursable under the West Bengal Health Scheme, subject to the condition that it is prescribed by a practicing Psychiatrist [MD in Psychiatry or a Diploma in Psychiatric Medicine, DPM]. However, the cost of therapies shall be admissible only if it is coded under WBHS.

All other terms and conditions in respect of medical attendance and treatment as an OPD patient in a hospital will remain unchanged.

This will take effect from the date of issuance of this order.
