MEMORANDUM

Pursuant to the constitution of the West Bengal Land Reforms Service vide this Department Notification No.1200-Estt dated 29.03.2023 and by virtue of the dictum of the Finance Department (as referred to in this Department's Memorandum No. 2759-Estt dated 08.08.2023), it has been observed that the officers (earlier designated as SRO-I) who joined in the WBLRS Grade-I in the year 1998 and 1999 are facing a financial loss in pay as they could not avail the benefit of MCAS'01 on completion of 25/24 years of service within 31.12.2023. Similarly, the officers who joined in the WBSLRS Grade-I (earlier designated as SRO-II) in the year 2007 and 2008 are also facing a financial loss in pay due to not getting the benefit of MCAS'01 on completion of 16/15 years of service within 31.12.2023 due to their absorption in the State Constituted Service ahead of the date of entitlement for MCAS benefit.

The removal of this anomaly was under the active consideration of this Department.

After careful consideration of the matter, the Governor is pleased to decide that the pay of the concerned SRO-IIs and SRO-Is whose 16/15 years or 25/24 years of MCAS benefit was due to them in 2023 with respect to their previous service but could not avail the same as they got absorbed in the newly-constituted cadre namely WBLRS w.e.f. 29.03.2023 prior to such respective dates of their entitlement , is to be recalculated/refixed in the WBLRS by allowing them one incremental benefit in the same pay level i.e. Level-16 or 17, as the case may be, with effect from such dates of their entitlement without having any bearing on their normal annual increment on 01.07.2023.

This order issues with the concurrence of Finance Department vide their U.O.No. Group P1/2024-2025/0632 dated 05.12.2024.
