Sub: Some specific cases

Respected Sir,

The Association likes to draw your kind attention in some specific issues as follows:-

1. The Case of **Sharmistha Dutta Roy**:

She was appointed as WBSLRS Grade - I vide Order No. 6339-Apptt./IE-188/2001 dated Kolkata, 16th August 2002.

Her batch of WBSLRS, Gr-I was promoted to SRO-II on 26.12.2011 vide order no. 8768-Apptt./IE-45/2011, dated 26.12.2011 while she was left out for reasons not conveyed to her.

Later, on 24.05.2018 the department, vide letter no. 2261/Apptt/IE-02/2018 dated 24.05.2018, admitted that she was never offered the said promotion and acknowledged that an error had occurred on the part of the Department in official communication.

Subsequently on 09.07.2018, she was promoted to the post of SRO-II. Though her position in the gradation list was not restored to the rightful place had her promotion not been deferred for eight years.

Later, her inter-se-seniority was finally restored at gradation serial no. 48A. Vide order no. 3820-Estt./3P-03/2023 dated 06.11.2024.

The matter was raised during discussion with the association held on 06.09.24 when we got the assurance from your kind end that the issue will be addressed; but even after several negotiations her absorption into WBLRS remains still pending lengthening the injustice done towards her without any fault on her part.

In view of the above, It is earnestly prayed once more to kindly consider her case and issue necessary orders for her absorption into WBLRS extending all consequential service benefits from their respective due dates.

2. The Case of **Piyali Pahari**:

Piyali Pahari, SRO-II, was not absorbed in WBLRS on and from due date presumably for pendency of departmental proceeding against her though no reason was disclosed, neither is there any such bar in the concerned rule.

Now that the proceeding has been concluded vide Order No. 1321- A&P/4A-13/2023 dtd. 26.03.25 of ACS and LRC, without curtailing any career benefit, her case may kindly be taken up for absorption on and from the due date on priority basis.

3. The Case of **Moral Hembram**:

Moral Hembram was denied absorption as A.D. because of a noting of SVC. Later on he got clearance. His batch mates have got absorbed as A.D. from 29.03.2023 and it is expected that he will be allowed so.

It has been almost six months since he has got the clearance but his file has not moved yet. You are kindly requested to look into the matter.

4. The Case of **Sunanda Ghosh Roy**:

The incumbent official had submitted SARs on time and was due to get absorbed from 31.12.2024. But because his case was not forwarded by the reporting officers concerned he has been denied promotion. He has submitted his individual prayer. Please look into his case.

5. The Case of **Rahul Dev Bagui**:

A case under section 13(2) read with 13(1)(b) under Prevention of Corruption act 1988 being number ACB - 11/22 was registered against the official. The charges with regard to taking of bribe is dealt with under section 7 of the Prevention of Corruption act 1988.

The charges leveled against him are related to illegally allowing somebody to use Government property. The said case has been enquired into and the final report submitted before the city session court, Kolkata Bench II on 19/12/24. The same has been eventually accepted by the learned court in presence of the public prosecutor and investigating officer on 6/3/2025. The official has been acquitted from all the charges. The required communication has been made to ADM (LR) 2025 and final report submitted on 4/4/2025.

6. Case of **Akbar Ali**.

The case of Akbar Ali: Akbar Ali, RO was not promoted, neither absorbed in WBLRS presumably due to pendency of departmental proceeding. Now that the charged officer Mr Akbar Ali has been acquitted from all charges vide memo. No. 2781 - A&P/3A-07/2022 dtd. 06.08.24 of LR and RRR Deptt he may be absorbed in WBLRS from due date and placed in approximate rank as early as possible.

The association fervently requests your authority to facilitate absorption of the said officials from due date.
