

Standard Operating Procedure for issuance of NOC for conversion of factory/karkhana land

ourpose	The purpose of the SOP is to create a guideline for dealing and disposal of the cases regarding issuance of No Objection Certificate for conversion of factory/karkhana land.
Scope	This will cover all such proposals of land conversion received by this department.
Step 1	Proposal for issuance of NOC for conversion of factory/karkhana land received by this Department directly from the concerned DL & LRO / Labour Commissionerate or directly from the applicant.
	Prima facie scrutiny of the documents submitted.
Step 2	 Application should contain at least: Formal application letter Any document establishing Identity (Aadhar Card, PAN Card etc) Details of land/ RoR Details of the Establishment
Step 3	All documents forwarded to the concerned DLC/ALC for: 1. Physical inspection of the location (present infrastructure/buildings/sheds) 2. Collection of all documents required as per existing norms (a) Whether the factory is operational /non- operational (b) If non- operational, factory /Karkhana Closure Report alongwith the reason thereof (c) Whether any dues/payment liabilities in respect of workers /labourers are pending (d) Any stipulatory dues (PF, ESI etc) pending / to be recovered (e) Is there any scope of revival of the factory/karkhana (f) Any other documents/records as may be applicable under provisions of Acts and Rules (g) Recommendation for N.O.C. by the concerned ALC/DLC/JLC 3. Scrutiny & Verification of all documents submitted by the applicant 4. Submission of Detailed report mentioning all details of the Inspection & verification including their views /opinion.
Step 4	On receipt of all necessary reports, scrutiny of the same done by the officials of concerned cell of this Department.
Step 5	If satisfied, NOC issued under the signature officer not below the rank of Joint Secretary of this Department subject to the approval of the competent authority.
